Is this a volunteer position?

No, Election Officers get paid for their services. <u>Please note: You must fulfill</u> <u>Federal I-9 employment eligibility</u> <u>requirements.</u>

Chief Officer	\$200
Assistant Chief Officer	\$150
Election Officer	\$100

What are the hours of service?

Election Officers <u>arrive at the polling</u> place at 5:00 a.m. and remain until all work is completed after the close of polls. The polls are open from 6 a.m. to 7 p.m.

Where will I be working?

Whenever possible, Election Officers are assigned to their "home" precinct. However, if there are no vacancies at your polling place, you may be assigned to a nearby precinct. Unassigned officers are asked to serve as "standbys" to fill in for scheduled officers who cannot serve.

What will my duties be on Election Day?

- Arrive at the polling place at 5:00 a.m. and remain until all assigned duties have been completed.
- Set up voting equipment and prepare the polling place for voting.
- Process voters by checking names against a list of registered voters.
- Admit voters to voting machines.
- Tally results.
- Close the polling place.
- In addition, the Chief Officer is responsible for returning materials to the Government Center on election night.

Another interesting opportunity is working in the Central Absentee Precinct (CAP).

- Officers work in teams to process mailed-in absentee ballots using optical scan voting equipment.
- Check names of voters against lists of absentee ballot applicants.
- Tally results of mailed-in and inperson absentee ballots.
- No standing is required.
- Absentee results are reported at the end of the night and are included in the unofficial results for the county.

What training is required?

Each election officer is required to attend training provided by the Office of Elections. Chief and Assistant Chief election officers are required by the Code of Virginia, § 24.2-115, to attend training prior to every election in which they serve. Classes, lasting about 2 hours, are held in mid-October at several locations around the county. Additional classes are held prior to special and primary elections. Training class schedules are made available online prior to elections.

When are elections scheduled?

- General Elections are held each year on the Tuesday following the first Monday in November.
- If primaries are called by the political parties, they are held on the second Tuesday in June.
- Town elections are held on the first Tuesday in May (Clifton, Herndon and Vienna).
- Special elections are scheduled as necessary.
